Listed below are the selections of bylaws by which each respective campus compensates their members from their Student Fee Advisory Boards.

All statements are **copied** from the University's individual bylaws and unaltered. Please note present language references:

*Education fees – Tuition

*Registration fees – Student Services Fee

Also attached is an Excel sheet with each campus' compensation rate listed on a table. This information was provided by respective campus Chairs as apart of the Council on Student Fess (CSF) initiative to review all campus practices. The Best Practices Campaign seeks to analyze each SFAC board, or otherwise campus equivalent, and monitor changes which benefit or hinder the success of each board.

UC Berkeley:

Unable to attain bylaws

UC Davis:

Each Council Chair and voting member will be compensated at a rate determined by the Vice Chancellor of Student Affairs in consultation with Student Employment. Compensation will be paid according to the pay calendar relative to the member's employment status. Compensation rates will be reviewed for adjustment every three years.

UC Irvine:

Students shall receive an annual stipend to be determined by the Executive Vice Chancellor and Provost.

If eligible, the Chair of the Committee will receive a stipend that is 40% more than that received by other Committee members receiving stipends.

Faculty and staff of the Committee are not eligible to receive stipends for service on the Student Fee Advisory Committee.

UC Los Angeles:

The base annual stipend was set at a fixed amount of \$3,000 for the 1997-1998 academic year. The base annual stipend should also be reviewed by SFAC every two years.

Student Stipend Policy currently outlines three key factors as meritorious of stipends:

1) The gravity of the responsibility and scope of interaction and impact on the general campus community.

2) The time required for participation inside and outside of regular committee meeting time(s) (i.e. Subcommittees, etc.).

3) Size of budget allocated.

UC Merced:

1) The Chair and Vice Chair shall receive a stipend equal to twice the full California resident Undergraduate/Graduate Student Services Fees for the entire year.

2) The Secretary shall receive a stipend equal to 1.5 times the full California resident Undergraduate/Graduate Student Services Fees for the entire year.

3) Each student member of SFAC that is not an SFAC Officer shall receive a stipend equal to the full California resident Undergraduate/Graduate Student Services Fees for the entire year.

UC Riverside:

Calculation and payment: Remuneration shall normally be computed on the basis that student Committee members receive payment for the equivalent of one (1) year's Student Services Fee (fall, winter and spring), the Vice Chair receives payment equal to one (1) year's Student Services Fee (fall, winter and spring), and \$3,000 stipend, and the Chair receives payment equal to one (1) year's Student Services Fee (fall, winter and spring) and \$6,000 stipend. University checks shall be prepared in three equal amounts and paid at the end of each academic term (quarter) unless otherwise specified by vote of the Committee

UC Santa Barbara:

Members will receive renumerations for their service on this committee. The Chair will receive payment for the equivalent of all fees, the Vice-Chair will receive payment for the equivalent of registration fees* and half of educational fees*, and the remaining student members will receive payment for the equivalent of their registration fees* and one third of their education fees*. Payment will be made in three equal amounts and will be paid at the end of each quarter. (Amended on October 21, 1996)

UC Santa Cruz:

Undergraduate and graduate student representatives are allocated a stipend at the end of each quarter of which they are actively participating on SFAC. In order to receive the full stipend, members must demonstrate sufficient participation in the committee through attending and participating in main committee work, subcommittee work, holding office hours, and reporting back to their representative spaces. Members will receive their stipends at the end of the quarter, after careful review and at the discretion of the Chair, Vice Chair and staff advisor from the Dean of Students Office.

UC San Diego:

For each academic year, the regular student members of the Committee will receive a stipend for their service equal to half the California resident Undergraduate Student Services Fees and Education Fees* for one Academic Quarter. The Chair shall receive a stipend for his/her service equal to half the California resident Undergraduate Student Services Fees and Education Fees* for three Academic Quarters. The Vice Chair shall receive a stipend for his/her service equal to half the California resident Undergraduate Student Services Fees and Education Fees* for three Academic Quarters. The Vice Chair shall receive a stipend for his/her service equal to half the California resident Undergraduate Student Services Fees and Education Fees* for two Academic Quarters.

UC San Francisco:

Unable to attain bylaws
